Newsletter Spotlight on AGM

The Annual General Meeting for the Saskatchewan Nurses Foundation will be held on Monday, May 9 at 5:00 PM in Regina and Saskatoon. In Regina, it will be held at SIAST, Wascana Campus in Rm 1130. In Saskatoon it will be held in Rm 308.2 (right inside the NEPS general office doors) at SIAST Kelsey campus. For those unable to physically attend the meeting, you will be able to participate by teleconference. Members will be notified of the toll free number to call in for the teleconference by email prior to the meeting.

Changes in Policy

The Board of the Saskatchewan Nurses Foundation has made some significant changes to the Policies of the Foundation. Programs that will be eligible for bursary funding will continue to include degree programs at the baccalaureate, masters, and doctoral levels. Eligible courses have been expanded to include clinical courses of more than five (5) days, professional development conferences and workshops, and Canadian Nurses Association (CNA) Certification exams. Implementation of these changes will occur in 2012, providing time for the Foundation to advertise the changes and create the application forms and guidelines. Further information will be available at the SNF Annual General Meeting.

A number of bylaw changes were also approved at the March SNF Board meeting. These bylaw changes will be presented to the membership at the SNF annual general meeting for ratification. A document outlining the changes and rationale will be circulated to SNF members prior to the AGM.

For the 2011 year, voting for directors will be conducted using electronic and mail vote. You will receive a ballot by email if you have provided the Foundation with an email address. If the Foundation does not have a record of your email address, a ballot will be mailed to you. Voting will close April 30, 2011.

A resolution from Council at the SRNA annual meeting in 1979 called for the creation of a trust fund “with the power to receive donations and invest same, and disburse funds to members of the SRNA for continuing education”. It carried and planning began for the Saskatchewan Nurses Foundation. The first donation was received from Peggy Rosso in June, 1979.

Update from the Board of Directors

The SNF Board met in January and March of 2011. Significant time was devoted to increasing the visibility of the Foundation, fundraising efforts to support the expanded bursary program, and to policy and bylaw revision. All policies were reviewed and significant changes were made to many, including those related to bursaries as noted on page one. Bylaw changes will be brought to the AGM for ratification. Planning is in the beginning stages to resume the SNF Founders’ banquet and live auction later in the year. The SNF website is in the process of being re-designed. Watch for the launch coming in the next few weeks. The brochure is also in the process of being updated. President Glenn Donnelly, Board member Larry Christie, and Executive Director Robin Evans were interviewed on Dave Morgan’s Listen Up program at 91.3 FM CJTR Regina community radio on March 1. The audio of the interview will be posted on the new SNF website.
